A. Payment

- Wave B (max 4 certwaves later than A): product is submitted for Base feature set (this feature set is always required,) fee: 63.000 + IPv6 (5.400) + DBC (9.000) + UCB (11.000) + Multicast (9.000): total fee is 97.400 Euro.
